WHEREAS, the Declaration was Amended by the First Amendment To Declaration of Restrictions: Bear Creek Estates and recorded June 14, 1991, in Official Records Book 2305, Page 1403, of Seminole County, Florida; and

WHEREAS, the Bear Creek Estates Homeowners Association, Inc., ("Association") desires to amend provisions of the Declaration, as more specifically set forth herein; and

WHEREAS, pursuant to Declaration Article X, Section 7, Amendment, the Declaration may be amended by obtaining the approval of the "Required Percentage" of (90%) of the Membership of the Association; and

WHEREAS, this Second Amendment has been approved by at least ninety percent (90%) of the total votes of the Association, pursuant to Article X, Section 7 of the Declaration; and
