Rosetta Villas HOA Roofing Project Guidelines

(Repair and Replacement)

All roofing projects (except emergency repairs as outlined below *) require prior written approval by the HOA's Architectural Review Committee (ARC) form. Owners must submit the ARC form directly to the management company in advance of the project. Please do not rely on your vendor to submit your ARC form for you. As outlined in our roofing guidelines.

- 1. Roof Repair Guidelines: Replacement shingles must be uniform in appearance (i.e., match in color, quality and size) to the existing or current shingles.
- * Emergency Repair Guidelines: Homeowners may proceed to take immediate action (i.e. tarping, plastic sheeting) to solve an urgent problem, such as a leak, prior to submitting an ARC form. Upon completion of the emergency repair, you must notify the Association Management within 15 days. Please note: If the repair is not in compliance with the Association's roofing guidelines, further repairs or corrections will be required.
- **2. Replacement of the Entire Roof**: Roofing materials (quality, style and color) must be consistent with the materials on the existing roof or with the materials (quality, style and color) on other ARC approved roofs in the subdivision.
 - A.) Roofing materials and shingle color must be compatible with the exterior paint colors of the home.
 - B.) The drip edge trim (along the edge of roof) must be "White" or match the existing approved fascia color.
 - C.) Roof vents and pipe sleeves colors should blend with or closely match the shingle color.
- D.) To preserve the individuality of the homes in the subdivision, shingle color should not be the same on more than three adjacent homes on the same street (e.g., if you are requesting a change in shingle color and the two homes next to you have the same exact shingle color, the ARC may request that you select a different shingle color.)
